

Investment Objective

The objective of the portfolio is to achieve high long-term capital growth.

Investment Concept

The portfolio is composed of a bond ETF (approximately 20%) and equity ETFs (approximately 80%). The weightings of the equity ETFs within the portfolio follow the idea of roughly reflecting the share of the individual regional markets in the global equity market at the time of issue. These weightings are restored in a quarterly rebalancing. There is no discretionary management done for this portfolio. It should be noted that the portfolio's objective is not sustainable investment and the underlying investments in this portfolio have no binding obligation to take account of EU criteria for environmentally sustainable economic activities as set out in Regulation (EU) 2019/2088 and in Regulation (EU) 2020/852. The portfolio does not have a dedicated ESG strategy.

Investment Horizon

The portfolio is primarily targeted at risk-oriented investors who have an investment horizon of at least five years.

Risk Profile

The portfolio is high risk. In addition to the typical risks associated with the ETFs or assets held in the portfolio (such as credit risks, interest rate risks), this portfolio has an exchange rate risk due to the different currencies of the ETFs contained within it as well as the diversification of the assets of these ETFs.


