

Investment Objective

The objective of the subfund is to achieve a high level of long-term capital appreciation.

Investment Concept

The sub-fund invests in equity funds denominated in EUR and other currencies (about 50% of the net sub-fund assets) and fixed-income securities (about 45% of the net sub-fund assets). The sub-fund may invest up to 10% of its net assets in real estate funds which are denominated mainly in EUR. It should be noted that the portfolio's objective is not sustainable investment and the underlying investments in this portfolio have no binding obligation to take account of EU criteria for environmentally sustainable economic activities as set out in Regulation (EU) 2019/2088 and in Regulation (EU) 2020/852.

The portfolio does not have a dedicated ESG strategy.

Investment Horizon

The sub-fund is primarily tailored to growth-oriented investors who have an investment horizon of at least five years.

Risk Profile

The sub-fund has a higher risk compared to a portfolio predominantly consisting of fixed-income funds. In addition to the typical risks of funds allocated in this sub-fund (such as credit risks, currency risks, interest rate risks), exchange rate risks may be incurred due to the different reference currencies in the funds allocated in the portfolio, as well as the diversification of the assets of these funds.


